If the wave pulse of wavelength $\lambda_{0}$ is produced at point A (Pulse 2) without disturbing the position of M it takes time $\mathrm{T}_{\mathrm{AO}}$ to reach point O . Which of the following options is/are correct?

[A] The time $\mathrm{T}_{\mathrm{AO}}=\mathrm{T}_{\mathrm{OA}}$
[B] The velocities of the two pulses (Pulse 1 and Pulse 2) are the same at the midpoint of rope.
[C] The wavelength of Pulse 1 becomes longer when it reaches point A.
[D] The velocity of any pulse along the rope is independent of its frequency and wavelength.
Sol. A, B, D
Speed of transverse pulse at the point $=\sqrt{\frac{\text { Tension in rope at the point }}{\text { Linear mass density of rope }}}$
So, $\mathrm{T}_{\mathrm{AO}}=\mathrm{T}_{\mathrm{OA}}$
Wavelength becomes longer when speed of the pulse increases.
*Q. 2 A human body has a surface area of approximately $1 \mathrm{~m}^{2}$. The normal body temperature is 10 K above the surrounding room temperature $\mathrm{T}_{0}$. Take the room temperature to be $\mathrm{T}_{0}=300 \mathrm{~K}$. For $\mathrm{T}_{0}=300 \mathrm{~K}$, and the value of $\sigma \mathrm{T}_{0}^{4}=460 \mathrm{Wm}^{-2}$ (where $\sigma$ is the Stefan-Boltzmann constant). Which of the following option is/are correct?
[A] The amount of energy radiated by the body in 1 second is close to 60 Joules.
[B] If the surrounding temperature reduces by a small amount $\Delta \mathrm{T}_{0} \ll \mathrm{~T}_{0}$, then to maintain the same body temperature the same (living) human being needs to radiate $\Delta \mathrm{W}=4 \sigma \mathrm{~T}_{0}^{3} \Delta \mathrm{~T}_{0}$ more energy per unit time.

When the mass loses contact with the block, its position is x and the velocity is v . At that instant, which of the following options is/are correct?

where x is displacement of the block.
$\mathrm{x}=-\frac{\mathrm{mR}}{\mathrm{M}+\mathrm{m}}$
From conservation of momentum and mechanical energy of the combined system
$0=\mathrm{mv}-\mathrm{MV}$
$m g R=\frac{1}{2}{m v^{2}}^{2} \frac{1}{2} M V^{2}$
$\therefore \mathrm{v}=\sqrt{\frac{2 \mathrm{gR}}{1+\frac{\mathrm{m}}{\mathrm{M}}}}$.
Q. 4 A circular insulated copper wire loop is twisted to form two loops of area A and 2 A as shown in the figure. At the point of crossing the wires remain electrically insulated from each other. The entire loop lies in the plane (of the paper). A uniform magnetic field $\overrightarrow{\mathrm{B}}$ points into the plane of the paper. A uniform magnetic field $\overrightarrow{\mathrm{B}}$ points into the plane of the paper. At $\mathrm{t}=0$, the loop starts rotating about the common diameter as
axis with a constant angular velocity $\omega$ in the magnetic field. Which of the following options is/are correct?

so, $\left|\frac{\mathrm{d} \phi}{\mathrm{dt}}\right|=\mathrm{B} \omega \mathrm{A} \sin \omega \mathrm{t}$
$\therefore \quad\left|\frac{\mathrm{d} \phi}{\mathrm{dt}}\right|$ is maximum when $\phi=\omega \mathrm{t}=\pi / 2$
The emf induced in the smaller loop, $\varepsilon_{\text {smaller }}=-\frac{\mathrm{d}}{\mathrm{dt}}(\mathrm{BA} \cos \omega)=\mathrm{B} \omega \mathrm{A} \sin \omega \mathrm{t}$.
$\therefore$ Amplitude of maximum net emf induced in both the loops = Amplitude of maximum emf induced in the smaller loop alone.
Q. $5 \quad$ For an isosceles prism of angle A and refractive index $\mu$, it is found that the angle of minimum deviation $\delta_{\mathrm{m}}=\mathrm{A}$. Which of the following options is/are correct?
