[#] The Central Government vide Notification No. 21/2015-ST dated 6 November 2015 has appointed November 15, 2015 as the date from which, Swachh Bharat Cess shall be levied on all taxable services at the rate of 0.5%, for the purposes of financing and promoting Swachh Bharat initiatives or for any other purpose relating thereto. Swachh Bharat Cess would be over and above the present Service tax rate i.e. 14%. Hence, the effective rate of Service tax including Swachh Bharat Cess will be 14.5% with effect from 15 November 2015.
